## CIRCULAR

HAJ – 2018 38

As per the information received from C.G.I. Jeddah, due to large scale construction work near Haram Sharif in Makkah Mukarramah in the areas which are traditionally occupied by the Indian Pilgrims. Hence only about **12,000** Green accommodation units are available in Makkah Mukarramah for the Pilgrims of Haj-2018. However, around 30000 selected Pilgrims have opted for Green category accommodation. In view of the shortage of accommodation units in Green category, the HCoI needs to downgrade nearly 18000 pilgrims from Green to Azizia as per Clause 16.2 (iii) of the guidelines for Haj-2018 and have to conduct qurrah.

Hence an opportunity is given to all the selected pilgrims (who opted for Green Category) to send their application for downgradation of category writing their cover number, name, address, if they so desire, by fax or email on or before 30-06-2018. (as per enclose performa). The applicants may also send their application for downgradation to their respective State /U.T. Haj Committees. Those who have already paid the amount for Green category will be refunded the amount before departure to Saudi Arabia

All the Executive Officer, State / Union Territory Haj Committees are requested kindly to give wide publicity to the subject matter. They are also requested to forward all such requests received from the selected Pilgrims of their State / Union Territory to Haj Committee of India.

Note: Those who have already applied earlier for change of category need not apply again.
