**Notification For Haj Trainers**

Online Applications are invited from the desiring Permanent Muslim Govt. Employees of the Jammu & Kashmir State for imparting training / orientation to the Pilgrims of Haj-2019. The eligibility criteria is detailed as under. The Training / Orientation is to be imparted as per the schedule in three phases of one day each.

**Eligibility criteria:**

- Must have performed Haj preferably during last 5 years and should generally not be more than 58 years of age, which is relaxed in case of deserving candidates.
- Must be fully conversant with English/Urdu language, eloquent in the local / regional dialects and computer literate.
- Must have thorough knowledge about the logistic and rituals of Haj & Umrah pilgrimage.
- Must be mentally and physically fit, capable of giving lectures to huge gatherings and in a position to spare time for imparting training.
- No criminal case should be pending against the desiring applicants in any court of law.
- Permanent State Subjects of J&K are only eligible.
- The applicants are advised to upload the requisite documents at the time of filling up of Online Application Forms for Trainers for Haj-2019

The interested applicants can apply online through Haj Committee of India website [www.hajcommittee.gov.in](http://www.hajcommittee.gov.in). The applicants shall have to appear for interview for selection as Trainers as per the schedule which shall be notified separately. The selected candidates shall have to attend two days Training Programme at Haj Committee of India, Mumbai. Aspirants are requested to go through the Circular No. 5 dated: 28-12-2018 issued by Haj Committee of India, Mumbai.

All desiring officers/officials fulfilling the stipulated eligibility criteria are required to submit hard copy of the online filled-in application form in original duly complete in all respects, alongwith copy of first page and visa page of passport, through the concerned Controlling Officers to the Executive Officer, J&K State Haj Committee, Srinagar upto 12-01-2019. Applications not submitted through Proper Channel, shall not be entertained.
