Subject: Haj 2019—Remittance of Advance Haj Amount @Rs.81,000/- each by the Provisionally Selected Pilgrims and subsequently Rs.1,20,000/- as First Installment Amount

It is notified for the information of all the Provisionally Selected Haj Pilgrims of Haj 2019 that they shall deposit the Advance Haj Amount and First Installment Amount on or before the dates as specified as under.

1	Advance Haj Amount	Rs.81,000/- (Rupees Eighty One Thousand Only)	5 th February, 2019
2	First Installment Amount	1,20,000/- (Rupees One Lac and Twenty Thousand only)	20 th March, 2019.

Mode of Payment: The Payment can be made electronically through Online mode on official website of Haj Committee of India i.e. www.hajcommittee.gov.in or manually into the Haj Committee of India Accounts maintained with State Bank of India Account No.32175020010 FEE TYPE-25 or Union Bank of India 318702010406009.

The pilgrims can remit both Advance Haj Amount and First Installment Amount on or before 5th February, 2019 if they choose to deposit the amount in one go. In case the selected Pilgrims fail to deposit the Advance Haj Amount of Rs.81,000/- on or before 5th February, 2019, their Haj Seats shall be cancelled without any further notice.

Deposition of Documents: After depositing the Advance Amount, the Provisionally Selected Pilgrims shall submit a copy of Pay-in-slip, Chest X-Ray report, Blood Report, Medical Screening & Fitness Certificate as per proforma already hosted on the website of J&K State Haj Committee www.jkshc.org alongwith original Machine Readable

International Passport with 2 passport size photographs (white background) on or before 5th February, 2019 directly at the office of State Haj Committee, Bemina, Srinagar.

However, in respect of Jammu and Ladakh Division, the Provisionally Selected Pilgrims can deposit the receipts of Advance Haj Amount / First Installment alongwith the requisite documents / Original Passports in the offices of respective Deputy Commissioners on or before 5th February, 2019.

The last and final installment shall be notified separately in the month of May / June, 2019.
