Notification for Khadim-ul-Hujaj

In pursuance to Haj Committee of India Circular No. 6 dated: 28-12-2018, read with Govt Order No. 12-Rev (Haj) of 2016 dated: 22-01-2016 online applications are invited from eligible Muslim Govt. employees (male only) for nomination as Khadim-ul-Hujaj with the pilgrims of the State for Haj-2019.

Eligibility criteria:

1. The applicant must be the Permanent State Subject of the Jammu and Kashmir State.
2. Muslim applicants (male only) of the age of 25 to 58 year as on 01-07-2019 are eligible.
3. Applicants, who have already performed either Haj or Umrah, will only be eligible. They should have good knowledge of Haj related activities.
4. Preference shall be given to those having knowledge of Arabic and experience of Hajj.
5. Applicants must be active persons of sound health with experience of management of public functions. Applicants must submit Fitness Certificate to this effect issued by a Government Hospital.
6. A "No Objection Certificate" from the Employer i.e., the Administrative Secretary in respect of Gazetted Officers and the concerned Appointing Authority in respect of Non-Gazetted Officers, must accompany with the hard copy of the Online Application Form.
8. No family member should accompany a Khadim-ul-Hujaj on Pilgrimage.
9. A person who has once served as Khadim-ul-Hujaj and against whom there are adverse observations by the Consulate General of India, Jeddah / State Haj Committee shall not be eligible .
10. Any applicant who has been on deputation as Khadim-ul-Hujaj thrice earlier and one who has been on deputation as Khadim-ul-Hujaj last year i.e. during Haj-2018 shall not be eligible to apply.
11. The eligible applicants shall have to appear for an interview before the Committee constituted by the Government for which the date shall be notified separately.
12. The applicants must be in possession of a machine readable Indian International Passport issued on or before **14th January, 2019** and valid at least upto **31st January, 2020** (attested copy of the passport to be attached with the application).

13. No TA / DA is admissible either during deputation or during attendance of trainings at Mumbai/ Interview etc.

The online application form can be filled on the official website of Haj Committee of India (www.hajcommittee.gov.in). Submission of hard copy of the online application form in the office of State Haj Committee is mandatory. In case any applicant fails to do so his candidature will be subject to rejection. The last date for receipt of had copies of the online application forms through Proper Channel , duly complete in all respects in Haj House, Bemina, Srinagar is **14th January, 2019.**

It is emphasized that hard copies of online application forms incomplete in any respect or received after the closing date shall be deemed summarily rejected for consideration without any further communication or correspondence / notice.
