Press Release

It is for information of all the selected Haj Pilgrims that they shall deposit the State Haj dues which include mandatory Insurance Premium, Transport charges from Haj House to Airport and other handling charges to be incurred by State Haj Committee as per the details given below. The Haj Pilgrims of Jammu Division who have opted Srinagar Embarkation Point and Haj Pilgrims of Ladakh Division shall have to deposit additional charges on account of boarding for their stay at Haj House, Srinagar. The concerned Pilgrims are required to deposit the receipt (pay-in-slip) of the amount at the office of respective Deputy Commissioners at the time of collection of passports and other travel documents. It is further informed to those Haj Pilgrims who have opted Delhi Embarkation Point for their departure shall have to deposit only Rs.150/- per pilgrim.

1. Pilgrims who do not want to avail the boarding facility at Haj House, Srinagar shall pay Rs.750/- per Pilgrim
2. Pilgrims who want to avail the boarding facility at Haj House, Srinagar shall pay Rs.1000/- per Pilgrim which includes Rs.250/- as boarding charges for one night.
3. Pilgrims travelling from Delhi Embarkation Point shall have to pay Rs.150/- per Pilgrim as Insurance Premium.
