**Notification for Haj 1445 (Hijri) 2024 (CE)**

It is for the information of all those aspirants who intend to undertake Haj journey 1445(H)—2024(CE) that Haj Committee of India has invited Online Haj Application Forms w.e.f **04/12/2023** and the last date for submission of same has been fixed as **20<sup>th</sup> December, 2023**. Before filing the application form online, the concerned Haj aspirants are hereby requested to go through Haj Policy available at Haj Committee website [www.hajcommittee.gov.in](http://www.hajcommittee.gov.in).

Applicants must be in possession of Machine-Readable International Passport issued on or before the closing date of application and valid atleast upto **31<sup>st</sup> Jan, 2025**.

**How to Apply:**

Haj Application form can be submitted **online** only at the website of HCoI i.e., [www.hajcommittee.gov.in](http://www.hajcommittee.gov.in) or on Haj App through Android Mobile App "Haj Suvridha" available on Google Playstore. While submitting the Haj Application Forms online, the pilgrims are required to **upload the following documents** as enclosures(s):


- i) First and last page of Passport.
- ii) Latest passport size photograph.
- iii) Copy of CANCELLED Cheque or a copy of Bank Account Pass Book of the person mentioned as cover head.
- iv) Address Proof: If the residential address of the applicant is same as mentioned in his/her passport, he /she may submit a copy of the passport as address proof. In other cases, the applicant may submit self – attested copy of any of the following as address proof: -

Aadhar Card/Bank Pass Book/Election Card:  
Electricity Bill/Telephone Bill/Water Bill /Gas Connection Bill.

**Note:**All the uploaded documents should be in **JPG Format** only.

- i) Passport size photo should be between **20KB to 100KB** and width between **100px to 148px**.
- ii) other documents sizes should be between **10KB to 500KB** and width between **570px to 795px**
