The participants are required to deposit the security amount of **Rs.5,000/- (Rupees Five Thousand only)** in the shape of Demand Draft drawn in favour of "Executive Officer, J&K Haj Committee" by or before start of auction announcement. The same will be refunded to unsuccessful participants after completion of auction process.
3. The successful auctioners will be required to deposit the whole auction amount by means of Demand Draft drawn in favour of " Executive Officer, J&K Haj Committee " or in cash within three working days.
4. The delivery of the auctioned vehicle will be arranged only after the successful auctioner submits documentary evidence in support of residential status (PAN Card, Aadhar Card, etc. in case of individual and Registration Certificate etc. in case of firms)
5. The auctioned vehicle will be removed by the successful bidder within 02 working days, after depositing the auction amount, at his or her own expenses.
6. J&K Haj Committee will not owe any responsibility for transfer of vehicle and for any other liability for using the vehicle for commercial or any other purpose after sale.
7. The successful bidder will also be responsible for getting Registration Certificate of the vehicle and/ or any other documents as required by the RTO, transferred in his name at his own cost expeditiously. This office will not be responsible for any lapses on his part in this regard.
