## Notification

The Arrival Phase of Haj flights is commencing from **2<sup>nd</sup> June, 2026**. As per the communication received from Haj Committee of India/Akasa Airline, the tentative arrival timing of Haj flights at Srinagar International Airport shall be as under: -

Due to the **NOTAM** and instructions on landing Aircraft with heady loads, luggage from Ahmedabad will be sent to Srinagar by road. Please note that immigration and customs clearance will be completed at Ahmedabad itself.

*To ensure a smooth journey, kindly follow the guidelines below strictly;*

1. **Hand Baggage**: - Only one hand baggage per pilgrim, with a maximum wight of 7KG will be allowed.
2. **Check-in Baggage for Srinagar**: - Each pilgrim can check-in only 5KG for the flight to Srinagar.
3. **Extra Baggage**: - Baggage more than 5KG (upto a maximum of 30KG per pilgrim will be transported by road from Ahmedabad (Gujarat) to Srinagar.
4. **Group Travel**: - To make travel and luggage handling easier, all pilgrims from the same cover group are requested to keep their Srinagar check-in baggage together.

5. **Single Piece Weight Limit:** - No single of check-in luggage should weigh more than 22KG.
6. **Collecting Road-Transported baggage:** - Pilgrims can collect their baggage (sent by road) from *Haj House Srinagar* once it arrives there.

The relatives of the pilgrims desiring of receiving the pilgrims at Srinagar International Airport can download the vehicle passes from our official website [www.jkshc.org](http://www.jkshc.org) prior two days of arrival.

The flight timing for remaining flights shall be notified separately.
