Subject: Selection of State Haj Inspector (SHI) for Haj-2025.

In pursuance to Haj Committee of India Circular No. 20 dated: 20-12-2024, online applications are invited from eligible regular employees of Central / State Government/Paramilitary Forces / Autonomous Bodies and PSUs of Central / State Governments for nomination as State Haj Inspector (SHI) for Haj-2025

Eligibility criteria:

- 1. The applicant must be the permanent residents of U.T. of Jammu & Kashmir .
- Male / Female applicants aged below 50 years as on 4th January, 2025 i.e born on or after 4th January , 1975.
- 3. Applicant, who has already performed either Haj or Umrah, will only be eligible (Visa copy of Haj or Umrah to be attached).
- -4. Minimum educational qualification of candidate applying for SHI is a graduation degree from a recognised institution.
- 5. Applicant must have machine readable valid Indian international passport valid at least upto 15th January, 2026 .
- 6. Applicants deputed to CGI, Jeddah as Khadim-ul-Hujaj more than thrice in his / her career will not be eligible.
- 7. Applicant must be active person of sound health so as to look after the pilgrims and to support the Haj operation.
- "No Objection Certificate" from the Employer i.e., Administrative Secretary in respect of Gazetted Officers and the concerned HOD / Director in respect of Non-Gazetted Officers/Officials, must accompany with the hard copy of the Online Application Form (Format of NOC enclosed as annexure-A).
- 9. Integrity Certificate duly certified / issued by DDO/Controlling officer as per annexure –B shall be submitted alongwith the application form.
- 10. Applicant must be tech-savvy, well acquainted with the use of smart phones, mobile applications, internet, conversant with Microsoft Office and fluent in language of the pilgrims that he / she shall be dealing with.
- 11. Applicant must be vaccinated with all the required doses of approved Vaccines interms of Health Guidelines issued by Kingdom of Saudi Arabia for the pilgrims of Haj-2025.
- 12. It is compulsory for the selected State Haj Inspector (SHI) to attend the Training Programme organized by HCoI for SHI, failing which their selection shall be cancelled.

- 13. Candidates against whom adverse comments have been received from CGI Jeddah during their past deployment on Haj duty as KuH or deputationist in KSA will not be eligible.
- 15. The eligible applicants shall have to undergo Computer Based Test followed by an Interview.

16. No TA / DA is admissible either during the period of deputation or attending Computer Based Test / Interview / Screening Test.

Employees working on Temporary / Part-time / Seasonal / Contractual / Ad-hoc basis and senior officers like Class A officers of Central or State Government or equivalent are not eligible.

The application has to be filled up Online through the official website of Haj Committee of India (<u>www.hajcommittee.gov.in</u>). The last date for submission of Online applications is 4th January, 2025 whileas the last date for receipt of hard copies of the online filled-in application form alongwith the following documents, duly signed and complete in all respects in the office of J&K Haj Committee, Haj House, Bemina, Srinagar is 11-01-2025.

Documents to be submitted alongwith hard copy of Online filled-in application form :

- 1. Copy of Adhaar Card / Domicile Certificate to be attached as district domicile proof.
- 2. Copy of Passport (front & back page)
- 3. Copy of Visa or any proof of Performed Haj / Umrah earlier.
- 4. Medical Fitness Certificate from a Govt Hospital.
- 5. No Objection Certificate (NOC) as per format.
- 6. Integrity Certificate as per format.
- 7. Copy of Office Identity Card / Last Month Salary Slip.

Applicants are advised to go through Circular -20 issued by Haj Committee of India in this behalf.

Note: No advance copy of application form shall be accepted by this office without enclosing all the requisite documents especially NOC.
